Dear Parent/Guardian

This morning, we were notified that Wrexham County Borough Council's Transport Department had informed the bus companies that they were to operate a 'No bus pass, No travel' policy, and for it to be operational from Tuesday, 2nd of September 2014. The school had not received any warning or any information about this.

This has obviously caused problems, uncertainty and concern for a number of pupils, parents and families at the start of this new term.

The management of arrangements and school transport contracts are the sole responsibility of Wrexham County Borough Council. As a school, we have contacted and had discussions with County officers in order to solve the problem.

This will be the arrangement for this week: Tuesday afternoon, 2nd September until Friday afternoon 5th September: each pupil who travel on a school bus will have permission to use the bus on the condition they have this letter to show the bus driver.

Under the direction of WCBC, the parents of all pupils without a valid bus pass must apply for and receive a new bus pass by Monday, 8th September 2014.
